


Fees

The table below shows our standard session structure and fees.

Extra sessions are subject to availability and charged at our full day session rate.



Fees are invoiced and payable monthly in advance by direct debit.

Hours

Opening hours: Monday - Friday, 7:30 – 18:00.

Full day session: 8:00 - 18:00.

Early drop-off available from 7:30, subject to availability.

We're open 51 weeks per year, excluding bank holidays. The nursery is closed between Christmas and New Year.



Deposit & Registration Fee

£200 refundable deposit.

£100 non-refundable registration fee.



Funding

15 hours of Government funding is available to all children for 38 weeks of the year starting from the term following their third birthday. We stretch this funding over the number of nursery operating weeks.



An additional 15 hours (totaling 30 hours) of Government funding is available if you meet the qualifying criteria.

The Government funding is for the provision of early years education only and does not cover the cost of consumable items such as drinks, meals, hygiene supplies, children's resources, or extracurricular activities and therefore these costs are factored in within the monthly charge.

A limited number of fully funded spaces are available.

Discounts

Discounts are applied for full time booking patterns as shown in the fee table.

We also offer a 5% NHS discount and 5% sibling discount, which is applied to the eldest child's fees if you have two or more siblings in nursery at the same time.



Session changes & notice period

Eight weeks' notice in writing is required for changes to your child's booking pattern or if you decide to leave the nursery.



Tax Free Childcare

Tax free childcare is accepted in our nursery and can be used with the 15 and 30 hours Government funding. This is available to all nursery age children. To apply for tax free childcare please visit www.gov.uk/tax-free-childcare.



Waiting list

A £50 holding fee applies to join our waiting list. We assess our availability on an ongoing basis and we will inform you if a place becomes available for your required start date and booking pattern. If we cannot offer you a place to start at the requested time, your child will remain on the waiting list until a place becomes available or until you request for them to be removed.



Settling In

It is important that your child feels settled in their new environment which is why we offer settling in sessions from up to 4 weeks before your start date. Please speak to your nursery manager for more information.



Offering places

Places are offered in the following order of priority:

- Existing children looking to increase their booking pattern
- Siblings of existing children
- Existing children transferring to another one of our nurseries
- Children on our waiting list whose preferred start date and booking pattern matches the available space
